The <u>Automatic Emergency Power I.D.</u> circuitry is configured to monitor the AC power input at the bridge rectifier. When AC power is supplied to pin E538, CR505 maintains 5VDC to E532, thereby enabling Track 1. The 5V is also applied to the base of Q508 which shunts voltage to E531 to ground; thereby inhibiting Track 2. When the AC power is lost, the 5V at the base of Q508 is lost, thereby allowing its collector voltage to go high. This then enables Track 2 by supplying the 5 volts applied through R535 to E531. If AC power is regained, the procedure is then instantly reversed.

I.D. MEMORY: If it is desired to change the ID (Call Letters) in the memory, contact Spectrum Communications. The factory can normally program and ship a new PROM chip within a few working days. Note that it takes special factory equipment to program the PROM IC - it is NOT field programmable. (Simply take the PROM out of its socket, and plug-in the new PROM.)
